By signing this form you also agree not to hold Justin's Canine Campus, its' owners, employees, or any other representative liable for any injuries or death to your dog(s) while in the care of Justin's Canine Campus.

I understand that Justin's Canine Campus in admitting my dog has relied on my representation of my dog(s) to determine that my dog is in good health, has not shown aggression, and has not harmed or exhibited threatening behavior toward any person or another dog.

I understand that by bringing my dog to Justin's Canine Campus I am granting permission for my dog(s) to socialize and intermingle with other dogs.

I acknowledge that Justin's Canine Campus is an open play environment and there are inherent risks which can occur even when monitored, and that injuries to dogs, owners or my guests might be reasonably foreseen to result from off leash play and socialization in the facility. I agree to accept responsibility for myself, my dog, and my representatives and will hold harmless Justin's Canine Campus, its' owners, employees, or any other representative for any injury or illness that may result from my use of the facility and its' services. I also acknowledge that transfer of communicable illnesses such as but not limited to kennel cough, viruses or parasites and/or injuries can occur. Most are benign such as broken toe nails, sore pads, abrasions, cuts or punctures particularly on shorter haired breeds of dogs. On behalf of myself, my dog(s), and my representatives I hold harmless Justin's Canine Campus for any costs, damages, claims or expenses that may incur from our use of the facility.

I understand that any behavior deemed dangerous or inappropriate may result in dismissal from daycare and if such behavior occurs Justin's Canine Campus will treat the behavior at their discretion and that I am solely responsible for any harm or damage that my dog causes.

I also acknowledge that I have received and read the *Dog Daycare Policies* and agree to the guidelines set forth.

## Dog Daycare Policies

1. **An appointment is required for daycare. We offer full days (drop off before 12:00pm and pick up by closing time) or half days (maximum of 5 hours and must be AM or PM; *morning half day reservations require pick up before 1:00pm, and afternoon half day reservations require drop off between 12:00pm- 1:00pm only.*** We limit the number of dogs in a play group and are unable to allow walk-ins for daycare. If you choose a set schedule, you will not need to call each time, though *we ask you notify us if you will not be in* on your regularly scheduled day. Please notify staff prior to pick up time if someone else will be picking up your dog.
2. **All dogs must wear a clasp collar and must be on leash when entering and leaving the building.** You must provide a regular “clasp” collar for your dog to wear during daycare (please, no belted or slip on type collars). We will store other collars/harnesses with the leash so that you may use it when coming/going.
3. **All dogs must complete a temperament evaluation.** We reserve the right to refuse or eject any dog that is determined to be a safety risk to any animal or person in the facility. This does not mean the dog is a bad or “aggressive” dog, it just means that daycare is not a good fit for him or her.
4. **All dogs must be spayed or neutered.** Puppies not yet of age for spaying/neutering will be considered on a case-by-case basis. Your vet will determine what age is appropriate for your dog’s breed to complete this. We allow a puppy to remain in daycare until their unaltered state starts to create difficulties within the playgroup; once a female goes into heat, she will not be able to return until after being spayed.
5. **All dogs must have current vaccinations for Rabies, Distemper, and Bordetella.** We need proof of vaccinations prior to the first day of daycare. Puppies can begin daycare after they have received their Bordetella and Distemper vaccinations; we will then need proof of the Rabies vaccination once received. **Any dog who tests positive for a contagious disease (i.e. canine cough, worms, puppy warts, Giardia, etc.) will not be able to return to daycare until we receive proof of clearance from the vet.** Please notify us immediately if this occurs.
6. **All dogs are required to have flea protection throughout the year.** Any dog that has fleas will not be allowed in daycare until resolved.
7. **A \$15 late fee will be charged for any dog picked up after 6:00pm.** If you know you will be late, please call to let us know so that we can plan accordingly.

Our goal is to provide a safe and fun environment to help your dog socialize with others and go home happy and tired. Our playgroups are staffed at all times and closely monitored for any signs of health concerns, behavior changes, or negative interactions with others. *Please understand that this is an active environment; dogs can sustain nicks and cuts while playing with each other, and may be wet at pick up from rain, snow or pool water.* Management will communicate any concerns that arise during daycare.
